#### ARTICLES OF INCORPORATION

The undersigned incorporator(s), a natural person 18 years of age or older, in order to form a corporate entity under the laws of the Marshall Islands, adopts the following articles of incorporation.

### ARTICLE I: NAME/REGISTERED OFFICE

The name of this corporation shall be MICROWAVE FILMS OF THE MARSHALL ISLANDS, located at PO BOX 3131, MAJURO, MARSHALL ISLANDS, 96960 (herein referred to as MFMI)

#### ARTICLE II: PURPOSE

The purposes of MFMI are:

- To develop, encourage and promote the culture of the Marshall Islands through the medium of film.
- 2. To encourage residents of the Marshall Islands to explore the Marshallese culture and life in the Marshall Islands through the medium of film.
